

Answers



Restorative justice must involve forgiveness from the person harmed

• This is not a requirement to participate in RJ. However, it can happen spontaneously and is down to personal choice of the person harmed

Restorative justice must involve an apology from the person who caused harm

 Again, this is not a requirement of a RJ. However, it can happen spontaneously and is down to personal choice of the person harmed

Restorative justice is used instead of a legal criminal process

 RJ is not be a replacement of the criminal justice system, but instead be an additional mechanism of justice for the person harmed. It can be used in conjunction with the criminal justice system, but it will never impact a sentence. RJ is often used after the criminal justice process is over



Answers



38% would take part in RJ for serious harms

• <u>False</u> - For serious crimes around half (51%) would probably or definitely consider it, and for less serious crimes this rose to 64%

Support for RJ was higher in relation to harms caused by children

<u>True</u> – the general public were more support of RJ when the harm was caused by a child

Support for RJ was more favourable in cases of more serious harm

<u>False</u> – the general public were more favourable of RJ for less serious harm

29% of the general public have heard of the term Restorative Justice

 <u>True</u> – only 13% of these respondents demonstrated a full clear understanding. The majority think RJ is about reparations for recent miscarriages of justice in court, e.g. individuals wrongly accused of crime being compensated



Answers



From a recent survey on RJ opinion in Scotland, what % of the general public thought RJ was a quite bad, or very bad idea?

• <u>True</u> – 17%

From a recent survey on RJ opinion in Scotland, what % of the general public thought RJ was a very good, or good idea?

• <u>False</u> – 69%



Definition



"... a process of independent, facilitated contact, which supports constructive dialogue between a victim and a person who has harmed (whether this be an adult, a child, a young person or a representative of a corporate or other body) arising from an offence or alleged offence."




